## Park Rules

**Office Hours:** 8:30am to 5:00pm daily

**Check In:** 3:00pm for Cabins/Units  
11:00am for sites (NSW Times)

**Check Out:** 10:00am (NSW Times)  
Late fees may apply.

**WIFI:** Please contact reception for details.

**Visitors:** All visitors must sign-in at reception before entering the park. Fees apply if staying overnight.

**Noise:** Quiet time from 10pm -7am. Please respect other guests and your neighbours. Fees may apply for after hours call outs.

**Fees:** All fees must be paid in advance. Rates include 2 adults; extra guests incur additional charges.

**Safety First:** We are committed to providing a safe environment. Report anything unsafe to the reception immediately. In an emergency or evacuation, follow staff directions.

**Park Management:** All guests must follow park rules and any reasonable instructions from park managers. Failure to comply may result in eviction.

**Site Occupancy:** Maximum of 6 people per site. Under 18s must be accompanied by a legal parent or guardian (park manager's discretion).

**Period of Stay:** Maximum stay is 150 days in any 12-month period for camping/tourist sites

**Children & Supervision:** Children must be supervised at all times. Children under 10 must be accompanied by an adult when using amenities.

**Smoking:** Not permitted in amenities, camp kitchens, or within 10 meters of buildings.

**Fires:** Campfires are allowed only in the northeast corner of the park, as shown on the map.

- **Restrictions:** No fires between 1 Sept - 30 Apr or during a total fire ban / in very windy conditions.
- **Safety Requirements:** Fires must be contained and the ground protected.
- Do NOT dispose of hot embers in any park bins.

**Laundries:** Located near amenities blocks. Machines require payment. No pet products or dog blankets allowed in machines.

**Vehicles & Parking:** One vehicle per site. Extra vehicles or boats must be approved and may incur a fee. **Speed limit is 5 km/h** (walking pace). Roads are shared zones—give way to pedestrians and bikes. No washing of cars, caravans, boats, or trailers.

**Pets:** Where permitted, pets are not allowed in amenities, camp kitchens, laundries, or BBQ areas. Do not wash pets or their items in laundries.

**Power Cords:** Only use 15amp power leads between 10m and 15m long for safety.

**Bicycles & Scooters:** Helmets must be worn. Maximum speed of 10 km/h. Avoid riding near amenities, check-in bay, or through sites. Not allowed after sunset. No electric-mode scooters/bikes permitted.

**Amenities:** Hot water is provided for showers and basins. Conserve water and limit shower times.

**Camp Kitchens:** Please clean up after use and be respectful of others. No alcohol in fridges.

**Your Site:** Keep your site tidy. Use drying lines and disposal points for sullage. NSW Law requires tents/caravans to be 2.5m apart. No perimeter barriers, wind breaks, or fences. Any extra structures must be approved by park management.

**Waste Disposal:** Wrap and contain waste. Use bins and recycling stations where available.

**Sullage & Dump Point:** Dispose of sullage and chemical waste only at approved points.

**Games:** Use grassed areas for ball games. Watch out for moving vehicles.

**Wildlife:** Do not feed native birds or animals.

**Wilful Damage:** Please leave your site in a clean and undamaged state. Costs for damage or excess cleaning may be charged to your card on file.

**Risks:** As per the Civil Liability Act 2002, all recreational activities are done at your own risk.
